

GDPR information clause for counterparties

Pursuant to art. 13 section 1 and section 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, "GDPR"), we hereby inform that:

- 1. The administrator of your personal data, that is the company deciding about the purpose and manner of processing your personal data, is Wielton SA with its registered office in Wieluri (hereinafter "Company").
- 2. The administrator has appointed the Data Safety Administrator (DSA). Contact with DSA is possible at the e-mail address: abd@wielton.com.pl or the phone number: 511 448 798.
- 3. Your personal data shall be processed for the purpose of contract performance. Processing of personal data for this purpose is performed based on art. 6 section 1 letter b) of GDPR. Personal data can also be processed by the administrator for the purposes of debt collection and pursuing of claims. Processing of personal data for such purposes is performed based on art. 6 section 1 letter f) of GDPR. Personal data can also be processed for the purpose of performance of obligations resulting form provisions of the law, including tax and accounting regulations. In such a case, the basis for data processing is art. 6 section 1 letter c) of GDPR.
- 4. Recipients of your personal data shall be entities authorized to obtain personal data based on provisions of the law. Data can also be provided to subcontractors of the Company, processing such personal data on behalf of the Company, based on personal data processing agreements.
- 5. Your personal data shall be stored for a period necessary to pursue possible claims, or for a period required under provisions of tax law, no longer, however, than 6 years after contract expiry.
- 6. You have the right to access the contents of your data, and the right to correct them, remove them, limit their processing, as well as the right to transfer your data.
